#### Summary

- BVB finished mixed and on very low turnover yesterday;
- Angela Merkel's comments pushed down the euro against the dollar; the leu lost 0.2% to the euro as well
- Hidroelectrica poses the question of raising the prices for regulated consumers

BVB finished mixed yesterday on very low turnover. The composite index BET-C gained 0.83% while BET-FI (-0.43%) and BET-BK (-0.48%) where the only indices to finish in the red. Fondul Proprietatea traded flat on the regular market but there was one deal where the stock lost 0.42%. All the SIFs were down yesteday, retreating from the previous days'gains. BET-NG gained the most (+1.93%), led by Rompetrol Rafinare jump (+10.51%) after it had been down yesterday. Transelectrica approved during the extraordinary meeting of general shareholders a new management system: it passes from a unitary system to a dualist system: therefore the management and control functions of the company become separate.

International equities' markets finished in the green yesterday, but Angela Merkel's comments regarding the uncertain prospects of the euro zone sent the euro down against the dollar yesterday and consequently, we sa'w the leu depreciating against the euro as well.

Domestically, it appears that the hydropower producer Hidrolectrica which has been declared insolvent since 20<sup>th</sup> June poses the question of raising the prices for electricity supplied to households as well. According to local newspaper Ziarul Financiar, Hidroelectrica intends to increase the prices for regulated consumers from 72 RON/MWh to at least 125RON/MWh, which is in fact the production cost. Already, Hidroelectrica has filed a law suit against the Romanian Energy Regulatory Authority to diminish the quantity supplied to regulated consumers and concomitanly operate the above mentioned price increase. Electricity weighs 5% into the consumers basket considered for the CPI calculation.
