# DAILY REPORT - ROMANIA

## **Summary**

- On the money markets, liquidity fell on Friday and ROBOR ON gained 46 bp reaching 5.94%
- The leu continued to appreciate; EUR/RON declined to 4.47
- The Treasury planned to sell 1 bn RON in government securities this week; last week, yields fell and the Treasury sold much more than the planned amount
- The President is meeting with parties' representatives who will indicate their proposal for prime minister

BET – C and BET advanced by 0.12-0.13% on Friday and the rest of the indexes finished in the red. BET-FI continued to mark losses, falling 1.1% on the day. In Europe, results were mixed and volatility was low. For today, futures signaled that the market expects stocks to mark some gains.

On the money markets, liquidity is decreasing and ON ROBOR rose to 5.94%, higher by 46 bp on Friday. Concomitantly, the leu appreciated further against the euro and EUR/RON dropped to 4.47.

Government securities yields came down on Friday, up to 14 bp in the case of 3Y bonds, but on a weekly basis results are mixed. This week, the Treasury plans to sell 1 bn RON. Last week, the Treasury sold much more than the planned amount and high demand pushed bonds' prices higher, interrupting the recent rise in yields.

President Traian Basescu is meeting today with representatives of the parties and national minorities which will form the Parliament, following the 9<sup>th</sup> December election. The representatives should indicate their proposal for prime minister and from USL, Victor Ponta is the candidate. Earlier this year, the President stated that if he will survive the referendum, he will not appoint Victor Ponta as a PM again.
