Summary

- BVB indices finished in the red yesterday but volatility was much lower than in Europe where major indices dropped 1-2%, in view of the recent events in Italy; in the US equities edged up after Ben Bernanke announced the continuation of stimulus;
- Transgaz net profit was 281 mn RON in 2012, lower by 27% YoY
- Money market rates are falling; compared to January, average ROBOR ON dropped around 65 bp and ROBOR 3M lost some 10 bp on average
- Government securities yields are lower on a weekly basis by 3-6 bp, except for 10Y bond yield which stagnated

BVB indices finished in the red yesterday, posting declines up to 0.7% in the case of blue chips' index ROTX. By comparison, major European indices lost much more, most of them losing between 1-2%. In Europe, the results of the election in Italy raised new concerns about the future of the euro-zone. On the other hand in the US, Ben Bernanke reassured investors of the continuation of stimulus measures which pushed the US equities 'slightly up. Back to domestic market, the equities 'turnover at BVB was 6.4 mn EUR and top traded stocks by value were 4 financial stocks (FP, SIF1, SIF2, SIF3) and OMV Petrom. Of the blue chips, there were 3 stocks that managed to gain: BRD (+0.33%), Banca Transilvania (+0.14%) and Transgaz (+0.1%). Several deals were made with 4 stocks: BRD, Fondul Proprietatea, SIF Transilvania and OMV Petrom. Transgaz reported preliminary results for 2012: net profit stood at 241 mn RON compared to 384 mn RON in 2012.

Money market rates are falling after NBR raised again the repo ceiling to 10 bn RON from 9 bn RON the previous week. In February, when the repo size was higher by 3.7 bn RON per week (on average) compared to January, the liquidity conditions improved: average ROBOR ON dropped by approximately 65 bp compared to January and average ROBOR 3M lost around 10 bp.

The leu is stable for the moment but recent events on the political scene slightly deteriorated risk perception in the region: the 5Y CDS (euro) has risen 11 bp yesterday and it is higher by 15 bp on a weekly basis. The EUR/USD was fairly stable as well yesterday and it closed at 1.3062 (mid) while leu's peers have seen little volatility too.

Government securities yields showed small movements yesterday of maximum 1 bp and they are declining on a weekly basis by 3-6 bp with one exception: 10Y bond yields stagnated.
