Summary

- Fitch has cut the long-term rating on the euro area's European Financial Stability Facility from AAA to AA+.
- The world's key stock markets achieved modest gains, with the Dow and the S&P500 hitting new highs again.
- Citibank posted better-than-expected quarterly figures.
- The euro zone, Britain, and the USA are to publish inflation data for June today.

Monday's trading on Western European stock markets started optimistically, but markets ran out of the initial impetus in the afternoon. The most probable reasons are the mixed American macroeconomic statistics and Fitch's move to cut its long-term debt rating on the euro area's financial stability mechanism, the EFSF (European Financial Stability Facility) from AAA to AA+, after downgrading France. The FTSE 100 and the CAC40 both climbed 0.6% higher, and the DAX rose by 0.3%.

At the beginning of Monday's session, American stock markets hovered near Friday's closing levels. Eventually, the Dow Jones upped by 0.13%, and the S&P500 added 0.15%, both hitting new historical highs. The Nasdaq kept 0.03% from earlier gains. Boeing was the strongest performer of the Dow's components, as the aircraft manufacturer soared 3.5%, making up for most of Friday's plunge.

Citibank's results beat expectations as its equity per share was at USD 1.25 (more than the forecast USD 1.17) in the second quarter, and it reported USD 20,002 mn revenue, better than the anticipated USD 19,476 mn. These figures, published during the day, have lifted Citibank's stock price by 0.9%.

Most of Asia's indices went up; after Monday's holiday the Nikkei added 0.6% on Tuesday.

The JPY's weakening led the USD/JPY closer to the 100 line on Monday, but this morning it started to appreciate again. On Monday, the EUR/USD sank below 1.3, only to end the day at the morning's level.

The New York Fed index came in better than expected but retail sales in June grew by a mere 0.4% month/month, falling short of the expected 0.8% increase.

The USA and the euro area are to publish inflation figures for June. In Britain, the year/year inflation was at 2.9% as opposed to the expected 3%. Today Germany is to publish the ZEW economic sentiment index for July.

Goldman Sachs, Coca Cola, and Yahoo are to publish their quarterly reports today.
