### **Summary**

- Europe closed mixed, and American stock prices mostly declined. Buyers turning up in the USA at the end of the session raised stock indices from their daily lows.
- The Bank of Japan left both its benchmark rate and its view on economic outlook unchanged.
- China's July trade balance surprised on the upside, suggesting that growth may stabilize.

European stock markets closed mixed, but most of them went down. Share prices in the USA extended their losing streak in day/day comparison. Buyers showing up at the end of the day helped to erase the losses seen at Wednesday's lows.

The Bank of Japan left its benchmark rate on hold and kept its economic view unchanged. At this point, central bankers are waiting to see whether the improving business climate gives rise to investments. The BoJ's leaders stick to their earlier pledge to increase the monetary base by JPY 60,000-70,000 billion per year.

In this morning's news, China's trade balance figure for July surprised on the upside. Both exports and imports grew faster than expected, in a possible indication that after two years of decelerating growth, expansion stabilized in the largest country of the world.
