American and European indices closed higher yesterday. US markets are closed for Thanksgiving today, and will have a shortened trading session on Friday.

This morning, Germany's DAX index stayed at a record high. Indices are unlikely to change on the America's holiday.

Switzerland's GDP grew by 0.5% in the third quarter (the expectation was 0.4%). In year-on-year comparison, the growth rate was 1.9%. The key drivers were exports and public expenditures. The SNB's next meeting is scheduled for 12 December. The Swiss National Bank's Governor Thomas Jordan said that the EUR/CHF threshold of 1.2 was unlikely to be altered at this point.

At the EU summit in Vilnius, Ukraine's president Viktor Yanukovych is having dinner with EU leaders tonight. Georgia and Moldova will sign initial political association agreement with the European Union. Ukraine is unlikely to sign the association and the free trade agreements, since the country's leader rejected to do so.
