**Summary**

- The key US indices climbed higher; favourable macroeconomic data came from the USA on Monday.
- Europe's major indices also closed in the green.
- Eurostat released declining inflation data.

America's major indices closed with gains yesterday: the Dow added 1.1%, the S&P and the Nasdaq upped by 1%, and the Russell climbed 0.6% higher. Yesterday's release of US industrial production figures turned out to be better than had been thought. The New York Fed manufacturing purchasing managers' index also rose, which bodes well for America's industrial activity.

London's Footsie advanced 0.6%, in Paris the CAC40 rose by 1.3%, and Germany's DAX closed 1.4% higher on Monday.

The sentiment in US trading remained uncertain. The small gains made by the Nikkei and the Hang Seng this morning may be attributed to the easing tension in Eastern Europe. Worries about the slowing Chinese economy have not evaporated from markets.

Industry was the strongest of the S&P's sector indices, with 1.2% increase. It was closely followed by the financial sector index (+1.1%).
