Summary

Date: 30.04.2015

- In March, the number of unemployed persons decreased further to around 594,000 (SA), while the unemployment rate slightly increased to 6.5%, because of the faster fall in the active population.
- On Thursday, the RON closed not too far from 4.42 against the EUR; this morning it was traded higher (around 4.43).
- The yield curve moved up by 2-6 bps, while MM rates decreased remarkably at the short end.
- On Thursday, Romania's equity indices recorded nice gains with one exception: the BET-FI edged down 0.5%. This morning, the BET opened slightly higher.

According to the National Institute of Statistics the unemployment rate (seasonally adjusted) marginally rose to 6.5% in March, even though the number of unemployed persons dropped to 594,000 from 597,500 in February; it stood close to 644,000 a year earlier.

This morning, the RON was traded around 4.43, above the level reached at the end of last week. The USD gained ground compared to the EUR.

Government securities' yields climbed 2-6 bps higher on Thursday, while money market rates significantly eased at the short end.

Despite the not too supportive global market sentiment, the BVB indices registered nice gains on Thursday with one exception: the BET-FI lost slightly more than 0.5%. The main index, the BET gained almost 0.9%, after the BRD advanced 3.2%, and the shares of Romgaz and OMW Petrom also climbed 2.0% and 1.8% respectively, while FP performed poorly (-1.1%). At the same time, the equities' turnover stood at relatively high levels, exceeding RON 41 mn. Today, domestic stocks mostly opened with thin gains.
