Summary

Date: 18.03.2016

- On Friday, the EUR/RON edged down a bit, but in weekly comparison the pair ended slightly higher.
- The MoF plans to sell RON 1 bn debt today.
- The BET rose by 1.1% on Friday.

After the sharp movements showed in the previous days, global financial markets finished a more quiet session on Friday. While the EUR/USD continued to march higher on Thursday, still fuelled by the Fed's lower expectations about the future path of the benchmark rates, on Friday the euro weakened somewhat, pushing the pair back below 1.13. This modest depreciation of the EUR was bolstered by a statement of ECB Chief Economist Peter Praet, who noted in a press interview that interest rates in the eurozone can still go lower. On Friday, the euro also lost ground slightly against the CEE region's currencies, including Romania's leu. Nevertheless, the EUR/RON climbed marginally higher on weekly basis.

Today the Ministry of Finance aims to borrow RON 1 bn through T-bills due in March 2017. On Friday, government securities' yield curve changed little, but yields eased 1-8 bps in weekly comparison with the exception of the 6M maturity, where the yield was flat at 0.47%. The ROBOR interest rates recorded limited variations last week.

In Bucharest, the key equity index, the BET outperformed its Western European rivals, pointing to a 1.1% gain on Friday. Banca Transilvania fared very well (+4.0%), continuing its Thursday's rally, which was triggered by news about the company's plan to pay record high dividends to its shareholders. In weekly comparison, the stocks of Banca Transilvania surged almost 13%. Among the BET's components, the second best performance was recorded by the FP (+1.6%), while Electrica also added 1.3% on Friday. On the other hand, the shares of OMW Petrom shed 1.2%. Equities' total turnover reached RON 42.4 mn, well above this year's average of RON 27.0 mn.

The main European benchmarks ended in the green zone, with the DAX and the CAC40 advancing 0.6% and 0.4% respectively, also helped by the supportive message of the ECB. Nonetheless, London's FTSE100 closed mildly lower (-0.2%). On the other side of the Atlantic, US stocks rose on the last day of the week, with the Dow and the S&P500 ending at their highest this year.

This week's macroeconomic calendar is relatively scarce. On Wednesday, the NBR will publish fresh statistics about the evolution of non-government loans and deposits in February. On the same day, the ACEA will reveal new commercial vehicle registration figures.
