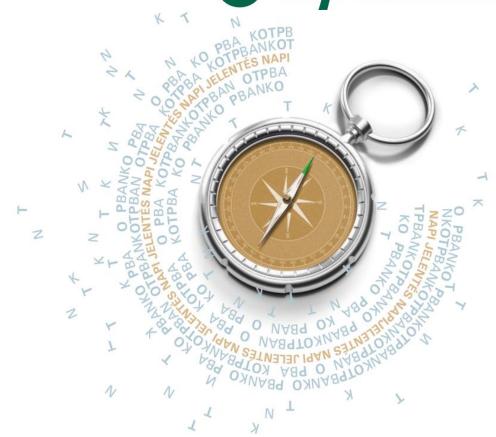

# **Global Daily Report**



### **Summary**

- Advanced stock markets moved little on Friday but Bitcoin nose-dived almost 10%
- The EUR/USD climbed somewhat higher, trading around 1.167

Advanced markets mostly headed down on Friday, losing up to 1%, with Western Europe's indices sinking deeper than their American peers. In America, General Electric rallied 2.5%, and Disney advanced 2.1% as investors appreciated the announcement that a completely new Star Wars trilogy is in the offing. In contrast, the price of Bitcoin slid 9.5% against the USD, due to hardfork issues.

In this morning's Asian trading the Nikkei fell 1,3%, while China's indices were heading higher.

By the end of Friday's trading, the BUX sank 2.1%, in what was the worst performance in Europe.

On Friday Fitch Ratings revised its outlook on Hungary's long-term sovereign debt rating from stable to positive, affirming the BBB- (investment grade) rating. The HUF did not react to Fitch's move.

The USD extended its losses on Friday: following its near-1,155 low hit on 7 November, the EUR/USD ended the week at 1,167. This morning the greenback was seen slightly appreciating.

Crude oil prices edged down but the WTI is still trading above 56 USD/barrel.

Today's important releases include the latest US budget data, due out at 20:00 CET. Later in the week, a number of European countries will release Q3 gross domestic product statistics on Tuesday.
