**Summary**

- This morning mostly favourable statistics came out about Romania's economy.
- Yesterday the EUR/RON climbed slightly higher (+0.1%); compared to the US dollar, the leu lost around 0.6%.
- Healthy demand characterised yesterday's bond auction.
- The BET outperformed its main rivals, posting 1.0% gain.

This morning the NIS published mostly favourable statistics about the country's economy. In January, the turnover index of market services rendered mainly to enterprises rose by 1.8% MoM (seasonally and working day adjusted data), lifting the annual growth rate of the indicator to 15.6% YoY, after December's 9.3% YoY. At the same time, the turnover index of wholesale trade also accelerated, posting 13.5% YoY gain, up from 7.1% YoY a month earlier, despite the fact that, in month-over-month comparison, the index was practically flat. Meanwhile, construction output gathered momentum, registering 7.1% MoM and 7.8% YoY advances in the first month of this year, supported by a revival in civil engineering works.

Today the NBR will reveal January's current account statistics.

Romania's leu slightly weakened against the EUR (0.1%), with the cross ending yesterday's trading near 4.67. In the CEE region, the PLN lost ground because of the surprisingly low inflation data, fuelling expectations that Polish National Bank will maintain its key rates at the current level for an extended period.

The Ministry of Finance sold more than planned in 9.3Y bonds (RON 560.2 mn vs. RON 300 mn), after primary dealers subscribed for RON 978.2 mn. The average accepted yield stood at 4.56%, up from 4.48% on a previous auction with the same ISIN in February.

European stock markets closed mainly in positive territory. Romanian Stock Exchange outperformed the main European indices and gained 1%, helped mainly by bank shares.
