Summary

- America's stock indices ended in the red on Friday; Europe closed mixed.
- The PMIs due out today are expected to drop slightly, but are unlikely to cloud the bright picture.

US stock markets started off hesitantly before a fall began on Friday. Of the Dow Jones Industrial Average's components, Apple (-4.0%) was under selling pressure while General Electric surged 4.6%, owing to the surprise figures in its earnings report. Other names climbing higher included Nike and Pfizer.

The sentiment in Western Europe was rather mixed: the stock exchange in Paris edged higher, while Frankfurt sank. London achieved gains. According to media reports, Porsche's head of engine development was arrested as part of the investigation into the diesel emission scandal, on concerns that the executive might flee or damage evidence.

The dollar's appreciation sent the EUR/USD to 1.228 on Friday, down from near-1.2375 level on Thursday afternoon.

Following Thursday's fall, crude oil prices moved sideways on Friday; the Brent traded at 74 USD/barrel on Friday night, and the WTI stood at USD 68.

Bitcoin rose steadily last week: recovering from its trough near USD 6,600, it traded above USD 9,000 on 20 April.

A string of important purchasing managers' indices is due out today. Analysts forecast a trivial dip in Markit's indices, but the indices are still at high levels in historical comparison. Any slip may be seen as a correction of the previous fast increase.
