Global Daily Report

Summary

- America's key indices fell sharply on Tuesday.
- The 10Y US Treasury Note yield has hit 3%.
- Iran's Foreign Minister threatened to withdraw from the nuclear weapons treaty.

Western Europe's stock indices closed mixed yesterday, with Britain's FTSE100 being the best performer (+0.4). In Europe, the PSA group's quarterly report caused disappointment as the 42% revenue growth was short of economists' forecasts; the carmaker slid 1% at the Paris stock exchange.

The sentiment was more downbeat in the USA, where indices trickled down right from the morning, and even an end-of-the-day recovery could not lift them into positive territory. Despite the cheering figures in the first-quarter reports of Coca-Cola, Caterpillar and Alphabet, investors opted to sell these shares. There were no obvious winner sectors on Tuesday but losers included industry, commodities and technology names.

Arriving at an important milestone, the US 10Y yield hit 3% yesterday, for the first time since January 2014. Drawing close to 2.5%, the 2Y yield also broke a multi-year record. The US dollar slightly dropped against the euro.

Speaking in an interview with the AP news agency, Iran's foreign minister said that his country would quit the nuclear weapons treaty signed in 2015 if the USA did so. This is Iran's reaction to Donald Trump's request to amend parts of the agreement by 12 May, or else the USA would unilaterally cancel its participation in the deal.

As expected, the MNB's Monetary Council left its base rate, as well as communication, unchanged. The Brent and the WTI both sank 1% yesterday. Precious metal prices barely moved.

Germany's IFO economic sentiment index, released yesterday, fell to its lowest in a year. This adds to the fears the Germany's economic growth may be slowing, particularly because last week's ZEW economic sentiment index undershot even the weak expectations.

Asia's trading ended with losses this morning; Hong Kong's Hang Seng index was hit the hardest. Japan's yen opened with losses versus the US dollar.

Today's important publications include the US oil inventories; the EIA is expected to report a drop in oil reserves.
