### **Summary**

- Europe's stock markets ended the day brightly but the gloom in the USA may undermine today's trading on both sides of the Atlantic.
- The UK is planning to tax the revenues tech giants earn from UK users.
- Angela Merkel's CDU party disappointed in a regional election in Hessen. The chancellor will step down as head of party and will not seek future reelection in Parliament.

Europe's stock markets started the week on a strong note: the Stoxx600 closed 1.3% higher on Monday, largely driven by car manufacturers' gains. Daimler rose by 1.3%, Volkswagen jumped almost 4%, while Peugeot advanced 1.4% on news that China was planning to halve taxes on car sales. Expectations that budget austerity is over in the UK helped the FTSE close 1.3% higher. Its rise was largely fuelled by the banking sector, with HSBC's share price surging 5% as its Q3 report surpassed expectations. Standard Chartered gained 2.6%, and the Royal Bank of Scotland grew by 0.5%. The DAX advanced 1.2%. In Italy, the Milan stock index upped 1.9% – apparently investors cheered that S&P did not downgrade Italy's sovereign debt.

The CEE region's indices posted gains on Monday. Growing by 0.5% made the BUX an underperformer, compared with the PX (+2.3%) and the WIG20 (+1.0%).

On the other side of the Atlantic, the pessimism has not eased. The Trump administration is planning to impose further tariffs on imports from China, unless a common denominator is found with China's leaders. The S&P lost 0.7%, the Dow fell 1.0% while the Nasdaq100 closed 2.0% down. The energy, industry, and technology sectors were the losers of the day. The UK Chancellor of the Exchequer announced plans to impose digital services tax on global technology companies starting from 2020; businesses with global revenue above GBP 500 million a year would be subject to 2% tax on the money earned in the UK. Amazon nose-dived 6%, Netflix slid 5%, Google plunged 4.5%, and Facebook slipped 2.3%. Microsoft fell 2.9%. Apparently, all segments of the technology world booked sharp losses.

German Chancellor Angela Merkel's stepping down as the CDU party leader triggered an immediate sharp loss in the euro. The currency was quick to recover, but remained highly volatile throughout the day. Having hit its lowest at 1.1361, the EUR/USD ended the day at 1.1371. The pound was driven by news on the UK'S 2019 budget: Chancellor of the Exchequer Philip Hammond said austerity was coming to an end. Expectations that government spending will grow helped the pound's appreciation; the GBP/USD sank to 1.2791, from 1.2831 on Friday.

The Mexican peso slid almost 4% yesterday. The country is to stop a costly airport investment project, President Andrés Manuel Lopez Obrador announced. Mexico issued bonds worth USD 6 billion, to finance the 13-billion-dollar development. Stopping this project harms investment sentiment, but the country will fulfil its contractual obligations, the President said. Elsewhere, the Brazilian real weakened 2% against the US dollar after the far right candidate Jair Bolsonaro won Sunday's early election in Brazil.

The Brent and the WTI descended 0.4% and 0.8% respectively yesterday. Copper price contracted by 1%.

Asia's stock indices closed mixed this morning: Japan's Nikkei upped and Hong Kong's Hang Seng dropped. Trade war fears subsided as President Trump's latest comment on possible import tariffs on Chinese goods became more refined.

Today the eurozone will release preliminary GDP data for the third quarter, and Germany will publish inflation data. Consumer sentiment index and housing price index statistics are due out in the USA.
