Summary

- Investors cheered at the outcome of US midterm elections.
- The US health sector was more than vigorous on Wednesday.
- The Fed is to make a rate decision today.

Wall Street posted hefty gains on the day after US midterm elections, as Republican majority in Senate reassured investors that the tax reforms implemented during Donald Trump's presidency would not be amended. At sector level, health care shares did extremely well as election results make a root-and-branch transformation of the health care sector less likely. With nearly all votes counted, Republicans boosted their control in Senate, while Democrats obtained huge majority in the House of Representatives. In Wednesday's press conference, Donald Trump spoke highly of the future Democrat Chair of the House and urged bipartisan cooperation.

Western Europe also welcomed the results but achieved smaller (around 1%) gains. The CEE region's stock markets could also benefit from the optimism: Poland's WIG20 (+2.1%) was the top earner; Hungary's BUX rallied 1.4%.

Commerzbank's quarterly report, published before markets hours, revealed a sharp fall in profits (year/year). The 2018 forecast has not changed since the previous quarter.

The yields on American 10Y government bonds trivially sank, while those on German bonds nudged somewhat higher yesterday.

When European stock markets opened on Wednesday, the USD was descending but despite a tiny uptick in the afternoon, the EUR/USD closed minimally higher. Emerging market currencies, including the forint, could mostly advance against the euro and the dollar, with the South African rand seeing the largest appreciation.

Even though investors expect a decline in Iran's oil exports on account of US sanctions, the steady rise in inventories drags prices down. Slowing from Tuesday's sharp fall, crude prices dropped more modestly on Wednesday. Reasons included a report by Russia's TASS news agency that Russia and Saudi Arabia are to discuss the possibility of holding back output next year.

In Asia, Japan Nikkei225 excelled in today's trading, closing 1.8% higher. The yen weakened versus the US dollar. China's Shanghai Composite dropped slightly.

In the USA, the Fed's rate decision is likely to be in the centre of attention today; FOMC members are likely to keep interest rates on hold (at 2.0-2.25%).
