Summary

- In January, Romania's current account deficit continued to widen.
- The EUR/RON was stable yesterday.
- The Ministry of Finance sold more than planned in a bond auction.
- On Monday, the BET closed in positive territory.

In January, Romania's current account (C/A) registered EUR 114 mn deficit, up from a gap of EUR 7 mn in the same month of the previous year, a NBR report said yesterday. It is worth mentioning that the current account used to register a surplus in January, due to seasonal effects, but this was not the case in the past two years. The twelve-month rolling deficit, a better indicator to capture underlying dynamics, pointed to a marginally higher gap (around 4.7% of GDP) than in December. Trade balance continued to deteriorate, as imports grew faster than exports. It is also important to add that the current account deficit is barely covered by stable financing sources, such as EU funds and foreign direct investments; this is starting to raise sustainability questions. We think that the C/A deficit may reach, or even exceed 5% of GDP at the end of this year, as rapidly rising wages will fuel consumption and, implicitly imports, while the weakening EZ economy is expected to constrain exports' growth.

Yesterday the EUR/RON cross was relatively stable, ending the day marginally lower (less than 0.1%). At the same time, government securities' yields mostly eased with the largest movement at the long end. The direction of yields was supported by the S&P's decision to keep Romania's rating outlook stable.

On Monday, the Ministry of Finance sold RON 274 mn debt via 10Y bonds. The auction was characterised by healthy demand, with investors subscribing for RON 679 mn.

Bucharest's key equity index, the BET rose 0.3% yesterday. Nonetheless, equities' total turnover was quite low (less than RON 18 mn).
