### Summary

- Thursday's trading sentiment was supportive in Europe and led to modest gains in the USA.
- President Trump announced tariffs on all goods from Mexico.
- Oil prices have dropped.

America's stock indices posted slight gains on Thursday. One factor that limited their growth was what a senior Chinese diplomat said: provoking trade conflicts was 'naked economic terrorism'; whereas President Trump maintained that trade talks with China were making headway. The Dow and the S&P rose by 0.2% each, and the Nasdaq100 closed 0.4% higher. In the corporate world, Uber's quarterly earnings report revealed USD 1 bn loss, in line with expectations. Its costs have jumped by 35%, partly because of expenses relating to its stock market listing, while revenues surged 20%.

In Thursday's supportive sentiment in Europe, London's FTSE100, Germany's DAX and France's CAC40 all gained 0.5% and the Stoxx600 closed 0.4% higher. Thus Europe's stock markets saw their strongest growth rate in the past five months. Media companies were the winners of the day. The share price of the Daily Mail sky-rocketed 9.6%, fuelled by its encouraging pre-tax earnings. Axel Springer rallied 22.2% on news that it may go private.

The GBP weakened against the EUR: the EUR/GBP climbed 0.2% higher.

Last night the US President announced to impose tariffs on all goods imported from Mexico, citing the intensifying immigration from the South. The new tariff will be effective from 10 June, starting with 5% rate, and it is to be raised by additional five percentage points in each month, before reaching 25% in October, unless immigration is reined by then. The news weakened the Mexican peso by 2.2% versus the US dollar. The stock prices of Japanese car manufacturers who export vehicles from Mexico to the USA also fell. Toyota reversed 2.9%, Nissan gave back 5.4%, and Mazda slid 7.1%.

Oil prices fell as the latest data point to a smaller-than-thought contraction in US oil inventories. Another reason for the lower prices is that USA-China trade war added to concerns that economic growth may be slowing worldwide. Brent and WTI fell 3.7% and 3.8% respectively.

Today the USA will publish statistics on personal income and spending. Elsewhere, Turkey is to release its GDP data for the first quarter. Any developments on the trade conflict also worth checking.
